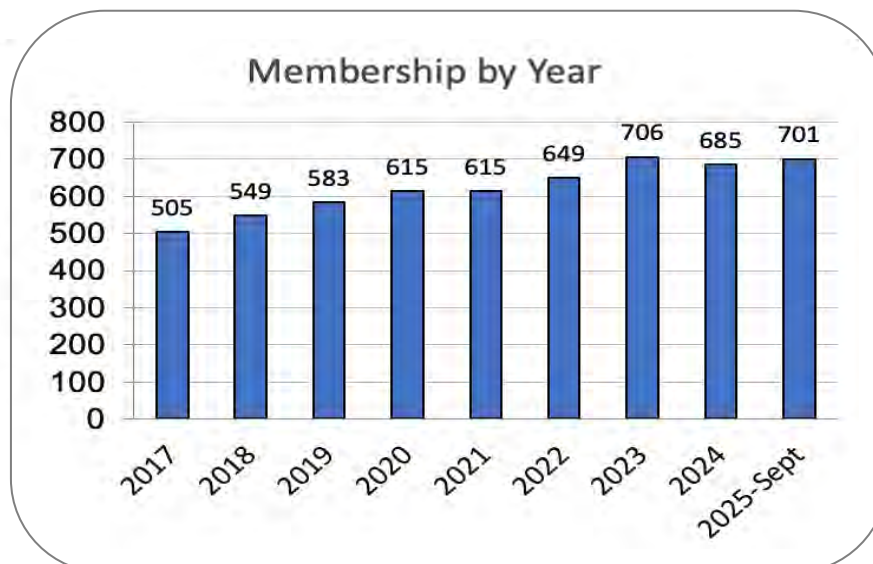
## Membership

### Name Tags

As a reminder, Committee Chairs whose new members need FOF name tags should contact [Membership](#), to arrange for new tags ordered through Sedona Engraving.

### Red Rock Pass

Courtesy annual Red Rock passes are provided to FOF members in appreciation for your volunteer efforts.

- If you already have the America the Beautiful Pass, then you do **not** need a Red Rock Pass unless you want to display one on your vehicle rear view mirror when parked.
- Members who volunteer at least **16 hours** during the Federal Fiscal Year (October 1 through September 30) are entitled to receive a free Red Rock Pass for the next 12 months.
- Members who volunteer at least **250 hours** during the Federal Fiscal Year are entitled to receive a free Federal Volunteer Pass for the next year.
- If you want both, then volunteer hours must be at least 266 hours.

The process for requesting a courtesy Red Rock Pass gives the Forest Service personnel (Rochelle) the opportunity to fulfill the requests in a streamlined manner.



- If your current pass will expire at the end of the month, [or you never had one] then send an email to [membership@fosedona.org](mailto:membership@fosedona.org).
  - Verify your mailing address and phone number in NEON (the FOF website that you log into to sign JHAs – choose “Update My Information” to view what is on file for you).
  - All hours will be verified and a request for the current month’s Red Rock Passes will be sent to the Forest Service on the **15th** of each month.
  - If you request a pass after the 15th of the month, your request will be processed the following month.
  - If you and your partner both require passes, then you both have to check your NEON profiles (some people have two homes and forget to update both accounts).
  - Make sure you provide the name of the person who wants the pass (for example, Morticia and Gomez Addams or just Gomez Addams)
- When you receive your Red Rock Pass, you **MUST** sign and return the acknowledgment form that will be mailed to you along with the Red Rock Pass.
- If you do not receive your pass by the end of the month that it was ordered, then email [Membership](#) and request a follow-up review to track it down. Occasionally passes get mailed to incorrect addresses, they were received a little late due to postal delays or just got missed. We’ll figure it out.

## Trail Ambassadors

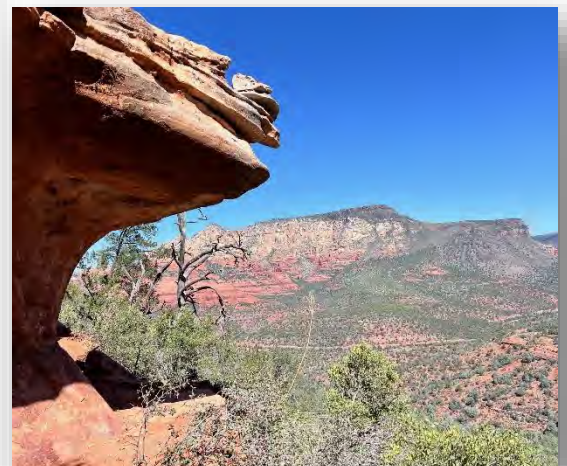

## Wildlife, Fish & Rare Plants



There is a dedicated group of **Wildlife, Fish and Rare Plants** volunteers who install and monitor Hobo Water Loggers in a variety of locations. Loggers are installed in April each year and retrieved in September. Timing is critical since the loggers are expensive and, during high water times, we don't want them in the streams.

Loggers (thermographs) are instruments used for monitoring physical conditions in aquatic systems. Temperature is an important component of water quality because it has several important effects on aquatic environments such as:

- It influences biological activity and growth.
- It affects water chemistry.
- It can impact water quantity measurements.
- It determines the kinds of organisms that live in water bodies.
- It affects the solubility of gases and chemicals in water testing.
- It is essential for understanding the overall quality and health of aquatic environments.
- It helps scientists study global warming, water cycles, and ecosystems.
- It defines growing seasons and dictates what species can survive in a particular body of water.

The location of those loggers are:

- Verde River where Sycamore Canyon comes in
- Call of the Canyon behind the bathrooms
- Oak Creek at Crescent Moon Ranch
- Spring Creek above the fish barrier
- Wet Beaver Creek downstream from Lawrence Crossing campground
- Walker Creek upstream from FR618
- West Clear Creek downstream from the campground off Hwy 260
- Fossil Springs (a major 4-mile hike one way to the actual site)

There is some legacy (baseline) data from the early 2000s from various Coconino Forest streams, and it will be interesting to see how temperatures may have changed over time. When the temperature of a body of water changes, either by natural or human-caused event, fish, insects, zooplankton, phytoplankton, and other aquatic species break out in a sweat (HA!!).

In addition to the ongoing drought, run-off from impervious surfaces such as streets and parking lots can also heat water, so the work that FOF volunteers do to accumulate more information is important and necessary.

## Water Sampling & Air Monitoring

We are almost through another summer here in Arizona and I just wanted to give a shout out to all the volunteers on the **Water Sampling and Air Monitoring Committee**.

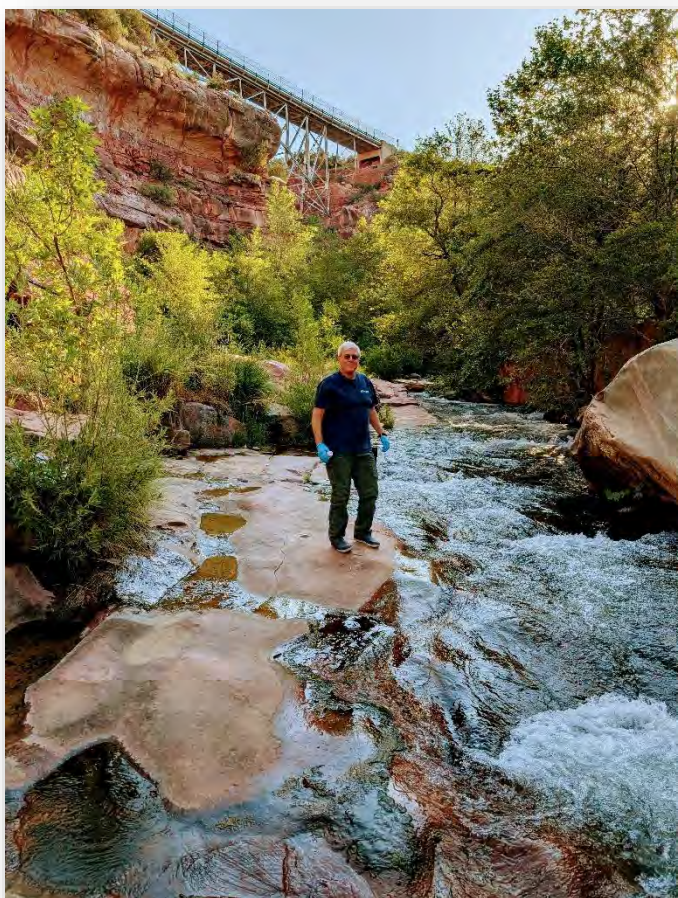
Volunteers currently sample Oak Creek in the summer months and Fossil Creek all year round. We couldn't do it without the dedication of the community scientists that grab samples, keep them cold, then get them heated up and go back to read the results the following day. It's a several step process that **Jessica Baldischwiler, Cynthia Malowitz** and a few other volunteers like **Ron Anderson, Michelle Swahla, Gary Malat** and **John Hogsett** have done this summer.

We are trained by ADEQ (Arizona Department of Environmental Quality) and also receive support from the Forest Service. We recently moved our lab to the Ranger Station from the Beaver Creek Work Center, with the help of Forest Service Volunteer Coordinator Toni Salazar. Thank you so much Toni!! She even hung a curtain for us so we could read the E.coli samples which need to be processed in the dark with a black light.

## Trail Maintenance & Construction

---

In April, the **Trail Maintenance and Construction** crew said our farewells to our departing Forest Service Trail Foreman, Holly Cliché.

Last year, we ended our season working on two of the projects included in the Red Rock Trail Access Plan, Doe Mountain and Turkey Creek.

At Doe Mountain we helped close off a number of social trails on top of the mesa and constructed a new loop trail.

At Turkey Creek we worked on the new Del Sol Trail which connects the Transept Trail with Turkey Creek. We also installed a new kiosk at the Transept Trailhead. **Rod Chasin** and the Sign Crew fabricated and installed new signage at both locations.

Our new season is ready to kick off. We'll start with a Bell Trail cleanup on September 12th. The Bell Trail takes a beating each year from all the summertime partiers enjoying themselves out at the "Crack."

As the Forest Service seasonal workers start to come on board we'll turn to more traditional TM&C projects. We'll start with the Oak Creek Canyon trails as we've got standard trail maintenance scheduled for Cookstove on September 19th, Harding Springs on September 26th, and Telephone on October 3rd. We'll then turn our attention to the buildout of the 20 some miles of new system trails planned for Turkey Creek.

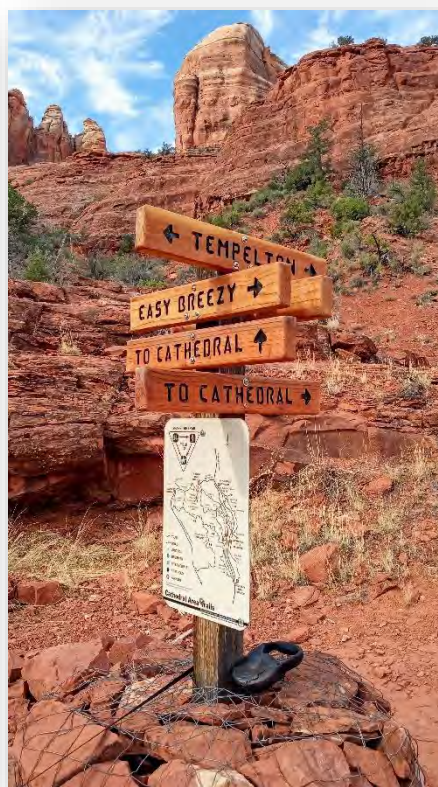


## Trail Maintenance & Construction Signage

Summer projects have included blaze markings on Del Sol, Submarine and Twin Buttes by **Steve Galginaitis** (see photo). **Ernie Dimillo** has created and installed new signage on Brewer at Coconino Loop with assistance from Steve.

## Preventative Search & Rescue

**Preventative Search & Rescue (PSAR)** had another busy year helping visitors survive their hot summer hikes. Over the course of 15 weekends, 35 volunteers spent over 1,000 hours at the Dry Creek and Bell trailheads providing advice, water, and assistance to nearly 10,000 visitors on their way to Devils Bridge and “The Crack.” Developed to assist first responders deal with the multitude of the heat related emergencies during the summer, PSAR also provided water to 4,000 hikers and aid to over 200, most of which were overcome by the heat. Many of the those in need of aid would have required medical attention from first responders if we weren’t there to assist.

Many thanks to the 35 FOF members who volunteered their time this season. Special thanks also go to my unofficial co-chairs; **Melissa Pontikes, Dave Terrill, and Annie Glickstein.** Their contributions were instrumental in making this year a success.

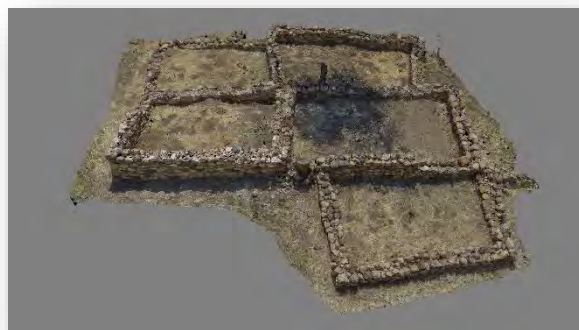

### Cultural Site Photo Documentation Project

The photogrammetry team has begun several more projects for the Kaibab and Prescott National Forests. These are not official FOF projects, but an assist to nearby affiliated agencies. Work has also begun on 3D photo documentation at Elden Pueblo in Flagstaff. Most project work has slowed considerably over the summer months as most team members are away for the summer. Even though team sizes are small, there is still a minimum number of people needed for each outing. Please contact [Spence Gustav](#) if you have any questions or would like to join his team.



### Site Recording Project

The Site Recording Project (SRP) resumed activity in late February, after a several-year hiatus per USFS request (i.e. no permanent District Archaeologist). Once again, it is under the leadership of **Scott Newth**. For this iteration of the project the team is made up exclusively of FOF members. The objective of this project is to professionally record (to include surface artifact analysis, mapping, and site schematics) prehistoric sites in the Red Rock Ranger District that were previously unknown to the Coconino National Forest archaeologists. These sites are away from the main tourist areas and are relatively pristine and need to be documented before

too much visitation. By analyzing the surface pottery sherds, we can identify culture and timeframe of occupation. There is a small team of six experienced individuals in archaeological site recording, and a few trainees. Seven sites were recorded-to-date in 2025 before hot weather and travel shut down the season until late October. Each site required multiple visits. One site yielded several pieces of St. Joseph black-on-white pottery which has never been recorded in the Verde Valley. Scott treated the team to a “fun field trip” to an extensive petroglyph site in the Prescott Forest to end the season.

### Docent Programs

The docent programs at the Crane, Palatki, & Honanki Heritage sites continue year-round. For the second year we have implemented shorter hours (earlier start times and shutting down at noon) at the sites to avoid the high afternoon heat. Palatki has also gone to a four-day week (Wednesday through Saturday) from June through September. This helps mitigate staffing issues for site hosts and docents, as many folks are out of town for all or most of the summer months. Many thanks to the stalwarts who have continued to volunteer throughout the heat!

We are always in need of new docents, particularly if you spend all or part of the summer months in the Verde Valley! Seasonal residents are wholly welcomed (and needed) too. Training is scheduled whenever we have members interested in the program.
